Sabin focuses on developing scientifically promising vaccine candidates with limited commercial potential, targeting diseases that affect the world's most vulnerable populations. Working with academic, public, and private partners, Sabin promotes open-source research. Current efforts include developing vaccines for Sudan ebolavirus and Marburg virus diseases using GSK's ChAd3 platform under a multi-year contract with the U.S. Biomedical Advanced Research and Development Authority.

The Sabin Vaccine Institute works to increase vaccine uptake and equitable access worldwide.
